Sir,

I am to state that the Council inspectors report 23<sup>rd</sup> & 24<sup>th</sup> January 2006 and 26<sup>th</sup> May 2006 for recognition of R.D. Gardi Medical College, Ujjain for the award of MBBS degree granted by Vikram University, Ujjain was considered by the Executive Committee at its meeting held on 14<sup>th</sup> & 15<sup>th</sup> June 2006 where the members of the Adhoc Committee appointed by the Hon'ble Supreme Court were also present and it was decided as under:-

"The members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council considered the compliance verification inspection report (26<sup>th</sup> May, 2006) and decided to recommend to the Central Govt. to renew the permission for admission of 6<sup>th</sup> batch of 100 MBBS students for the academic session 2006-07 at R.D. Gardi Medical College, Ujjain.

However, the recommendation of the Committee with regard to recognition of R.D. Gardi Medical College, Ujjain for the award of MBBS degree granted by Vikram University will be placed before the General Body of the Council as and when held for its consideration and approval".

The matter along with the above recommendation of the Executive Committee was placed to all the members of General Body of the Council by circular on 29.11.2006 for its consideration and their opinion / observation within 10 days upon receipt of the said communication. Otherwise, it would be deemed to treat their approval if no communication is received from them within the stipulate time.

Since, no opinion/ observation was received from the members of the General Body, their deemed approval/ratification on the recommendations of the Executive Committee is treated.

You are therefore, requested to issue necessary notification at the earliest recognizing R.D. Gardi Medical College, Ujjain for the award of MBBS degree granted by Vikram University, Ujjain.


