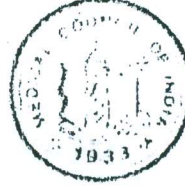

Act, 1956 restricting the number of admissions to 02(Two) student(s) per year."*

The attention of the institute is drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21<sup>st</sup> July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.

You are requested to issue notification recognizing the above qualification on or after September, 2012.
